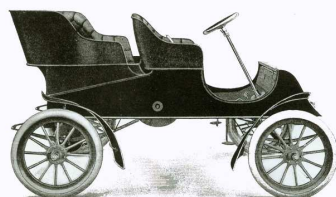
Also if you have a question you've been meaning to ask about anything pertaining to Early Ford automobiles, here's your chance. We welcome any curiosity you might have.
